- C. A GENERAL PUBLIC LIABILITY INSURANCE AGAINST CLAIMS FOR BODILY INJURY, DEATH, OR PROPERTY DAMAGE IN AN AMOUNT NOT LESS THAN \$ 2 000 000.00.

1. <THE ELEGANT WEDDING BRIDAL SHOWCASE > SHALL NOT, UNDER ANY CIRCUMSTANCES, BE LIABLE IN RESPECT OF ANY LOSS, INJURY OR DAMAGE SUFFERED BY < THE COMPANY > NAMED HERE WITHIN OR ANY OTHER PERSON AS A RESULT OF ANY ACTIVITIES OF THE EVENT, AND / OR OCCURRING AT THE LOCATION, FROM ANY CAUSE WHATSOEVER, WHETHER OR NOT THE DAMAGE RESULTS FROM THE NEGLIGENCE OF ELEGANT WEDDING BRIDAL SHOWCASE, ITS MANDATARIES, EMPLOYEES OR OTHER PERSONS FOR WHOM THEY MAY BE LEGALLY RESPONSIBLE.
